

NOTICE OF RACE

North Sea Regatta 2025

Organizing Authority: Jachtclub Scheveningen Saturday June 7 - Monday June 9, 2025 North Sea, Scheveningen, The Netherlands

This event is open for the following classes:

• 29er	Class Event
 Flying Dutchman 	Class Event

The notation '**[NP]'** in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1.

1 RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing (RRS). The Prescriptions of the RNWA can be found at <u>World Sailing - Racing Rules of Sailing</u>
- **1.2 [NP]** Boats shall sign out and in each day. Boats failing to comply will be penalized without a hearing. A detailed procedure per class and the penalty system is described in the sailing instructions.
- **1.3** For **all classes** the World Sailing Offshore Special Regulations 2024-2025 (OSR) Appendix B Part A and Part B apply in addition to the class rules.

The following also applies if similar requirements are not included in the class rules:

- Each crewmember shall wear an approved personal flotation device of at least CE50 Newton standard, or equivalent
- Boats shall have an extra tow rope of at least 7 meters length and at least 8 millimetres of diameter attachable to the front of the boat.
- For centerboard classes each crew member will wear a Wetsuit or Drysuit while racing
- For centerboard classes each crew member will have at least one approved personal signal on his person while afloat
- For Keelboats: each boat shall carry at least one approved personal emergency signal (flare)
- A magnetic or electronic compass is required
- A VHF device and GPS are recommended.
- Every competing boat in the RS500, 29er and 49FX class shall have a supporting person on the water, known by the organizing authority . No more than 6 racing boats per support person.
- **1.4** Boats shall only be launched or leave their berth with permission of a member of the Race Committee.
- **1.5** If there is a conflict between languages the English text will take precedence.
- **1.6** Every person on board who has his domicile in the Netherlands shall have the appropriate license.
- **1.7** The GDPR declaration which can be found at <u>GDPR - Jachtclub Scheveningen (powered by e-captain.nl)</u>
- **1.8** RRS Appendix T, Arbitration, applies.

2 SAILING INSTRUCTIONS

2.1 The Sailing Instructions will be available on the event website on or before Monday 19 may 2025. Other documents governing the event will be published with the Sailing Instructions.

3 COMMUNICATION

3.1 The official notice board is online only and located at <u>https://www.manage2sail.com/NSR2025/onb</u>.

- **3.3** On the water, the race committee may make courtesy broadcasts to competitors on VHF radio. The channel will be stated in the SI. This article is no ground for redress.
- **3.4** Briefings, team leader meetings and hearings may be conducted using an online video meeting application.
- **3.5 [DP]** While racing, except in an emergency or when using equipment provided by the race committee or Organizing Authority, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- **4.1** The regatta is open to all entries from classes stated on the title page of this Notice of Race. With respect to our operational capacity, the OA will decide not later than May 1, 2025 which of the mentioned classes can participate in the 2025 edition. The number of complete registrations per class (which include payment) will weigh heavily in the OA's decision.
- **4.2** Minimum number of entries to establish a separate class is 10, based on the number of paid entries on May 1, 2025, although the OA may accept lower numbers. An additional entry fee may then be charged. Alternatively, classes may be cancelled or combined on a rating basis or started together, such at the discretion of the OA. The entry fees for canceled events will be refunded.

Eligible boats may enter by registration with the Organizing Authority at the website <u>https://www.manage2sail.com/NSR2025/register</u>. To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees

- **4.3** By entering minors under the age of 18 years, the person in charge declares that their parent or guardian agrees with the entry.
- **4.4** Online entry for all classes is open from Saturday February 1, 2025 and closes on Wednesday May 14, 2025, 18:00 (local time).
- 4.5 Competitors that have entered after Wednesday May 14, 2025 shall only be accepted after written approval of the Organizing Authority.
 Competitors can request a cancellation of their entry by sending the Organizing Authority an email to info@nsr.nl. In case such a request is made before Wednesday May 14, 2025, 24:00 (local time) and is accepted by the Organizing Authority, the entry fee will be reimbursed after deduction of an administrative fee of €15.00.

4.6 Sailors from the Russian Federation or Republic Belarus and/or with the Russian or Belarus Nationality and/or sail under the Russian or the Belarus flag are permitted to enter the NSR only on an individual basis. Representing their country is not permitted.

5 FEES

5.1 Fees are stated in Euro and include any local taxes. The entry fee is only payable online.

- **7.1** Boats may be required to display bow numbers, backstay flags, competitor bibs and advertising chosen and supplied by the Organizing Authority.
- **7.2** The Organising Authority may require boats to carry tracking and timing devices according to the Sailing Instructions.

10 [DP] EQUIPMENT INSPECTION

- **10.1** [DP] Boats and equipment may be subject to inspection at any time during the regatta.
- **10.2** Classes may organize measurement or equipment inspection. This will be announced and specified in the Sailing Instructions.
- **10.3 [DP]** Boats shall also comply with RRS 78.1 when presented for inspection.

12 VENUE

- **12.1** The race office is located on the first floor of the club house of Jachtclub Scheveningen, Hellingweg 98, 2583 WH Scheveningen, The Netherlands.
- **12.2** Addendum A shows the location of the regatta office and harbor
- **12.3** Addendum B shows the location of the inshore racing areas.

13 COURSES

- **13.1** The course to be sailed, will be windward/leeward or trapezoid courses
- **13.2** The course descriptions are included in the sailing instructions.

14 PENALTY SYSTEM

14.1 RRS 60.3 is supplemented as follows: On the last day of the regatta, it is not possible to lodge a measurement protest for deviations of the measurement rules which could have been protested earlier in the series.

15 SCORING

- **15.1** RRS Appendix A will apply.
- **15.2** Four races are required to be completed to constitute a series for each of the individual series prizes.
 - a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
 - b) When 5, 6, 7 or 8 races have been completed, a boat's series score will be the total of her race scores discarding her worst score.
 - c) When 9 or more races have been completed, a boat's series score will be the total of her race scores, discarding her worst two scores.

16 [DP] SUPPORT PERSON VESSELS

16.1 Support vessels with team leaders and other support personnel shall stay outside areas where boats are racing from the time of the starting sequence until all boats have finished, or the race committee signals a postponement, general recall or abandonment.

17 CHARTERED OR LOANED BOATS

17.1 A chartered or loaned boat may carry national letters or a sail number in contravention of her class rules, provided that the race committee has approved her sail identification before the first race.

18 [NP][DP] BERTHING

18.1 (Support) Boats and trailers shall be kept in their assigned places in the boat park or harbor.

19 [DP] HAUL-OUT RESTRICTIONS

Not applicable.

20 [DP] DIVING EQUIPMENT AND PLASTIC POOLS

Not applicable.

21 RISK STATEMENT

- 21.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
- **21.2** The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

22 [NP]INSURANCE

22.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 per event or the equivalent.

23 PRIZES

23.1 Prizes will be awarded to the top 3 boats in each class. Special North Sea Regatta perpetual trophies will be available. A description of these trophies will be published on the online notice board at www.manage2sail.com.


